

REQUEST FOR PROPOSALS Improvement of Designated Restrooms for Hale Ola 'Akahi

BACKGROUND: In operation since 1992, Waimanalo Health Center (WHC), a federally qualified health center, provides comprehensive health services for all who seek care regardless of their ability to pay. Services provided at WHC include primary care, dental, behavioral health, optometry, traditional Native Hawaiian healing, nutrition education and counseling, care coordination, outreach and eligibility services, WIC, and a youth mentoring program. WHC's mission statement reads, "Waimānalo Health Center is committed to providing the highest level of primary and preventive health services, with special attention to the needs of Native Hawaiians and the medically underserved, and improving the health and wellness of individuals and their `ohana regardless of their ability to pay."

LOCATION: This is a project for Waimanalo Health Center located at 41-1347 Kalaniana`ole Hwy TMK (1)4-1-09:279

PURPOSE AND DESCRIPTION: The purpose of this request for proposals (RFP) is to solicit proposals from various vendors to upgrade and improve designated restrooms used by patients and employees, and address energy and water saving equipment/mechanisms within this process. The outcome of this engagement is to provide WHC with necessary plumbing services for WHC's designated restrooms by replacing toilet bowls/tanks as well as sinks and faucets where necessary. The current restrooms are located in the A-Building Hallway. This building is mostly vacant at this time. See Attachment A-Existing Floor Plan for the identified spaces.

Plumbing Work Description

- Assess the functionality of the existing toilet bowls, toilet tanks, urinals, sinks and faucets.
- Remove and dispose of existing toilet bowls/tanks, as necessary. There are currently 7 toilet bowls/tanks and 2 urinals within 3 restrooms.
 - \circ $\;$ Replace and install any removed toilet bowls/tanks and urinals.
- Remove and dispose of sinks and faucets, where necessary. There are currently 5 sinks/faucets within 2 restrooms.
 - Replace and install any removed sinks and faucets
- Repair existing lines where necessary.
- Dispose of all waste from project site.

TIMELINE: The timeline must align with WHC's work hours of 8:00am – 5:00pm Monday – Friday. Saturdays are available as an option. WHC is expecting work completion within 2 weeks of start date.
